



Do Dham Kedarnath & Badrinath

Date 30 Aug to 6 September

Kedarnath and Badrinath

Kedarnath and Badrinath, two of the most revered Hindu pilgrimage sites, are located in Uttarakhand, India, offering spiritual significance and breathtaking Himalayan views.

Kedarnath

Kedarnath, in the Rudraprayag district at 3,583 meters (11,755 feet), is near the Mandakini River. The Kedarnath Temple, dedicated to Lord Shiva, is a key part of the Chota Char Dham Yatra and one of the twelve Jyotirlingas. Built by the Pandavas and restored by Adi Shankaracharya in the 8th century, it's

accessible from late April to November. Pilgrims embark on a spiritually enriching trek from Gaurikund through the majestic Himalayas.

Badrinath

Badrinath, in the Chamoli district at 3,133 meters (10,279 feet), lies along the Alaknanda River. The Badrinath Temple, dedicated to Lord Vishnu, is part of the Char Dham Yatra. Attributed to Adi Shankaracharya in the 8th century, the temple has been renovated multiple times. Pilgrims visit from April to November, seeking blessings and bathing in the spiritually significant Taptkund hot spring, surrounded by stunning Himalayan peaks.

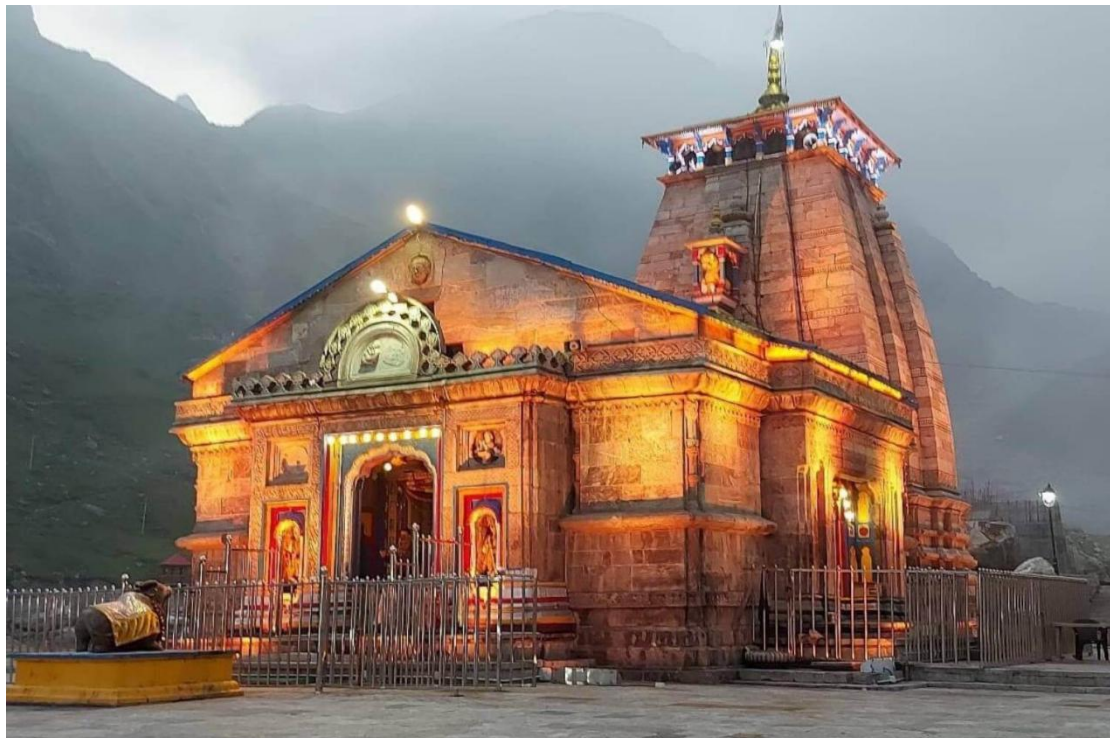
30 August Day 1: Delhi to Sonprayag (452 KM Drive / 12 Hours)

****Inclusion: Transport + Stay + Dinner****

Meet our driver at Hotel/Railway station/Bus stand and drive to Sonprayag. On the way, you can see the Mandakini River at Tilwara. The Mandakini River comes from Kedarnath. Drive along the river to reach Sonprayag. Visit Ardha Narishwar Temple in Sonprayag.

31 August Arrival

On arrival at Sonprayag, check in to the hotel. Enjoy a fresh vegetarian dinner at the hotel. Night halt in Sonprayag.



1 September Day 2: Sonprayag to Kedarnath (5 KM Drive / 16 KM Trek)

Inclusion: Transport + Stay**

Morning after breakfast, we will go to Kedarnath. You have two options to reach Kedarnath:

By Trek:** In the morning, our driver will drop you at Sonprayag. You then take a local jeep to Gaurikund and start your trek to Kedarnath Ji. You can also take a horse, doli, pittu, or palanquin from Gaurikund at your own cost. After Kedarnath Ji Darshan, come back to your hotel. Overnight stay in Kedarnath. Next day, trek back to Sonprayag. Parking is a big problem in Sonprayag, so keep your driver's phone number with you and call the driver upon reaching Sonprayag.

2 September Day 3: Kedarnath to Sonprayag (16 KM Trek)

****Inclusion: Transport + Stay + Dinner****

This morning, after darshan at Kedarnath Temple, have breakfast and reach Sonprayag/Phata by trek or helicopter.

Drive to the hotel and check-in.

Overnight stay at the hotel in Sonprayag.

By Trek:** When you down-trek from Kedarnath to Sonprayag, inform the driver about the estimated return time. Once you reach Gaurikund from Kedarnath, you can take a local jeep to Sonprayag. Keep the driver's contact number with you in case of parking issues and call him when you reach Sonprayag so that he can pick you up and drop you at the hotel.

3 September Day 4: Sonprayag to Karnprayag/Joshimath (Situational)

****Inclusion: Transport + Breakfast + Dinner + Stay****



After breakfast, drive to **Karnprayag/Joshimath (Situational)**.

Check in to the hotel on arrival in **Karnprayag/Joshimath (Situational)**



September 4 Day 4: Karnprayag/Joshimath (Situational) to Badrinath

After breakfast get ready to depart for Badrinath.

Pilgrims, after having a bath in the Taptkund, have the Darshan of Badrivishal and join Aarti in the evening.

There are other interesting sightseeing spots just under 3 KM from Badrinath Ji, like Mana, Vyas Gufa, Maatamoorti, Charanpaduka, Bhimkund, and the "Mukh" of the Saraswati River.

After dinner, overnight stay in Badrinath.

5 September Day 5: BADRINATH TO Haridwar (300 KM / 8 Hours)

Inclusion: Transport + Breakfast + Dinner + Stay

Begin your morning with a refreshing bath in Taptakund, followed by a visit to Badrivishal for darshan. After seeking blessings, enjoy a hearty breakfast before setting off on your drive to Haridwar via Joshimath. Along the way, make a stop at the sacred Dhari Devi temple, known for its serene environment and spiritual significance. Continue your journey with a visit to Devprayag, where you can witness the stunning confluence of the Alaknanda and Bhagirathi rivers, forming the holy Ganges.

Upon arriving in Haridwar, check into your accommodation, freshen up, and relax. End your day with a delightful dinner and an overnight stay in Haridwar, ready to explore more or continue your journey the next day.



6 September Day 6 Haridwar to Delhi



Start your day early with a hearty breakfast at your hotel or a nearby café. After packing your belongings and completing the checkout process, head out to explore Haridwar. Begin with a visit to the vibrant local market where you can buy souvenirs, spiritual items, clothes, and local handicrafts. Don't forget to try some local snacks and sweets. Next, visit the famous Har Ki Pauri ghat on the banks of the Ganges. Here, you can witness the sacred rituals and take a holy dip if you wish. Afterward, take the cable car (ropeway) to Mansa Devi Temple, perched on a hilltop, offering stunning views of the city and

surrounding area. For more panoramic views and spiritual ambiance, visit the Chandi Devi Temple, also accessible by a ropeway.

By mid-morning, start your journey towards Delhi. Enjoy the scenic drive and aim to reach Delhi by 7:00 PM. This itinerary ensures you make the most of your morning in Haridwar before heading back to the bustling capital.

Please note that if your package includes a flight which is a low-cost carrier (Air Asia, Scoot Airlines, Air Arabia, Jetstar, Vietjet, Fly Dubai, Thai AirAsia, Air India Express, Tiger Airways) then baggage will not be included in the package. Baggage can be added as per your requirement at an additional cost depending on the airlines and destination. TCS Conditions:

As per section 206CCA of Income Tax Act 1961, w.e.f. 01-Jul-21 onwards, TCS will be charged @10% on overseas tour packages in case you have not filed your income tax returns for two preceding years; and the aggregate TDS and TCS in each tax year is INR 50,000 or more.

On validating the PAN if it is found that you have not filed your Income Tax Returns for two preceding years and aggregate TDS and TCS exceeds INR 50,000, an additional TCS @5% will be recovered from you or booking will get cancelled and cancellation charges will apply.
